**TO ALL THE QUALIFIED, REGISTERED VOTERS OF THE COUNTY OF BEXAR,
TEXAS:**

Take notice that the County of Bexar will conduct a Constitutional Amendment Election, and a Joint General, Special and Bond Election with the San Antonio River Authority, the City of Castle Hills, Converse, the City of Hill Country Village, the City of Sandy Oaks, the City of Schertz, the City of Windcrest, the Green Valley Special Utilities District, the Somerset ISD, ESD #4 and ESD #11 on Tuesday, November 5, 2019.

The County of Bexar will hold an election to adopt or reject the proposed Constitutional Amendments as submitted by the 86th Legislature, Regular Session, of the State of Texas, and separately published by the Secretary of State.

The San Antonio River Authority will hold a General Election for District 1 Director in Bexar County. The City of Castle Hills will hold a Special Election. The City of Converse will hold a General Election for Mayor and Places 1, 3 and 5. The City of Hill Country Village will hold a Bond and a Special Election. The City of Sandy Oaks will hold a General, Special and Bond Election. The City of Schertz will hold a General Election for Mayor and Council Members, Place 1, 2 with a Special Election for Place 4. The City of Windcrest will hold a General Election for Mayor and Place 4 and 5 and a Special Election for Place 1. The Green Valley Special Utilities District will hold a General Election for 2 Directors. The Somerset ISD will hold a Bond Election. ESD #4 will hold a Special Election. ESD #11 will hold a Special Election.

The polling places for voting on election day, Tuesday, November 5, 2019 from 7:00 A.M. to 7:00 P.M. will be the same as those used by Bexar County, as published on November 3, 2019. For the first time, voters will be able to cast their votes at any of the election day poll sites. We are using the Vote Center model approved by the Secretary of State.

Early voting by personal appearance will also be conducted at locations, dates and times as listed in the attached.
