- Automobile tires with NO RIMS
- Oil-based/Flammable/Combustible Paint
- Oven cleaners
- Metal polish
- Photo chemicals
- Floor cleaners
- Radiator cleaners
- Wood preservatives
- Oil based paint
- Solvents
- Sealants
- Antifreeze
- Engine and radiator fluids
- Old home chemistry sets

- Herbicides
- Rodent killers
- Hydrochloric acid
- Creosote
- Batteries
- Latex Paint
- Drain cleaners
- Kerosene
- Arts & crafts supplies
- Moth Balls
- Dry cleaning fluid

- Prescription, Non-Prescription Pills
- Prescription/Non-Prescription Liquids
- Prescription/Non-Prescription Creams
- Prescription/Non-Prescription Patches
- Pet Medications
- Vitamin & Herbal Supplements
- Inhalers

* NOTE: Leave items in original containers & Black out all personal Information – Do Not cover up name of medications

DO NOT BRING WE ARE UNABLE TO COLLECT THE FOLLOWING ITEMS:

- Trailer tires, tractor tires, tires with rims
- Agricultural Chemicals
- Dioxins
- LARGE Appliances like washers, dryers, chest type freezers
- A/C Units
- Containers Larger Than 5 Gallon
- Large Propane Cylinders
- Radioactive Materials

- Industrial or Commercial/ Business Waste
- No Compressed Gas Cylinders
- Explosives including Ammunition
- Items with Asbestos or Mercury
- Construction and Demolition Debris
- Scrap Metals

PHARMACEUTICAL WASTE:*

- NO Sharps
- NO Syringes
- NO Oxygen Tanks
- NO Pen Needles
- NO Lancets

* Check with your health-care provider for proper disposal procedure for these items.

- Bring products in their original containers.
- Do not mix or consolidate products.
- Properly seal containers to prevent leaking.
- Haul containers in the trunk or back of vehicle, away from passengers.
- Collection site personnel have the right to refuse material not considered appropriate for this event.
