Fiesta Medal Market Hours and Information

- Setup: 8:30 AM – 10:30 AM
 - All support vehicles must be moved to the vendor parking area by 9:30 AM
- Event Hours: 11:00 AM – 3:00 PM
 - Each booth must be setup by 10:30 AM
 - Each booth must be open and have a vendor present throughout the event
- Tear Down: 3:00 PM – 3:30 PM
 - Each booth must be open until 3:00 PM, tear down can begin at 3:01 PM
 - Vehicles will be allowed near vendor area once deemed safe by River Authority staff

Fiesta Medal Market Rules & Information

- There are no fees to participate in this event
- Booth spaces will be 10' x 10', unless otherwise specified
- Power will not be provided, generators will not be allowed
- Fiesta Medal Market participants must supply their own equipment including, but not limited to tents, tables, chairs, merchandise, etc.
- Fiesta Medal Market participants will keep their space clean throughout the event, properly dispose of all trash, and clean their space after the event
- Fiesta Medal Market participants must sign and return an event release prior to the event
- The River Authority will not provide insurance for Fiesta Medal Market participants
- Fiesta Medal Market participants are responsible for obtaining, and being able to provide, licensing, permits, or certifications; Including but not limited to Texas Sales Tax & Use Permit, Federal Tax ID#.
- Fiesta Medal Market participants including their employees, agents, and volunteers at the event must adhere to all city, county, and state of Texas regulations

Fiesta Medal Market Rules & Information, cont'd

- All solicitation and/or sales must take place within your 10' x 10' space, social media advertising is allowed and encouraged
- Fiesta Medal Market participants agree to allow use of video and photography by River Authority, any videos and photos taken by River Authority are the sole property of River Authority
- River Authority expressly disclaims and negates any implied or express warranties for the Fiesta Medal Market participant's space. Parties' expressly intend that the property be licensed on an AS IS, WHERE is basis
- River Authority reserves the right to cancel the event at its sole discretion and will undertake best efforts to notify Fiesta Medal Market participants if the event is canceled in advance as well as inform participants of alternate event date, if any
- River Authority reserves the right to cancel Fiesta Medal Market participants license for this space at any time and/or to refuse applicant/vendor's future applications should vendor fail to abide by these rules
